Dear Property Owner,

Attached please find a copy of the Locke Lake Colony Association applications for a building permit. This application is required under our deeded Restrictions and Easements, also attached. There is no fee for this application. It needs to be returned to the Association's office either in person or by mail to the above address. Our office is open 9:00 am to 4:00 pm Monday through Friday and 9:00 am to 7:00 pm on Tuesdays during the winter months, and also from 9:00 am – 12:00 pm on Saturdays in the summer.

Any new construction or any construction increasing the footprint of an existing structure being performed on an Association owned/maintained road will require an inspection by a representative of the Association to determine the existence and care of the culverts and review the driveway plans.

Please be aware that under our Restrictions and Easements the exterior of the construction must be completed within six (6) months (Sec.4-d). Furthermore, all accounts must be paid in full or written payment agreement between the parties is established prior to any approvals for construction being granted by Locke Lake Colony Association.

- All exterior improvements, upgrades or construction must be completed within 6 months from the date construction began per deeded Restrictions & Easements. (attached)
- A town building permit must be obtained and posted at the construction site, visible from the roadside before construction can begin.
- Please submit a copy of all detailed plans along with your application.
- A copy of the Town of Barnstead's permit and land/lot survey must be submitted to Locke Lake Colony Association prior to any construction begins.
